EVENT GUIDELINES

Tires: Hoosier Tires ASALM (35) on the left side of the car. ASALM (45) on the right side. All competitors will be allowed to purchase a maximum of FOUR (4) tires. Each team must use their event tires for qualifying, and feature. All Practice tires must be bought at the track.

Rulebook: All competitors understand that by submitting an Entry Form for an ASA Late Model Series Event, they have read the ASA Late Model Series 2007 Official Rulebook and all technical bulletins issued by the ASA LMS in 2007. Competitors also agree to abide by these rules and regulations as well as any changes that may be ordered by ASA LMS Officials at any event.

Membership Policy: All car owners and drivers must obtain an ASALMS membership license to be eligible to participate in an ASA Late Model Series Event.

Decal Policy: All participating cars in an ASA LMS sanctioned events are required to display ALL decals in their assigned locations as outlined by the 2007 ASA LMS Decal Placement Sheet. Decals MUST be in place prior to any on-track appearance at an ASA LMS event. Failure to comply with the decal placement assignment subjects the entrant to fine, loss of points and/or prize monies, probation and/or suspension.

Uniform Policy: All drivers are required to wear a full-coverage, fire retardant, ONE-PIECE driver's uniform (recommended SFI spec. 3.2 A/5) specifically designed for racing, fire-retardant GLOVES (recommended SFI spec. 3.3/5) and fire retardant SHOES (recommended SFI spec. 3.3). Driver's helmet MUST conform to Snell Foundation SA2000 Standards or SFI spec. 31.1A (open face) or 31.2A (closed face) and have confirmation sticker visible for inspection. Drivers are REQUIRED to wear eye protection at all times.

Use of an approved head-and-neck restraint device is MANDATORY. Additionally, all drivers are required to display designated patches of SERIES SPONSORS and MAJOR SPONSORS in their designated locations.

Spotters: It is the responsibility of all car owners participating in an ASA LMS-sanctioned event to supply a qualified individual spotter and that spotter must report to the assigned ASA LMS Official in the spotters' stand prior to the car being allowed on the track.

Starting Field: The field will consist of 26 cars, with positions 1 through 20 coming from qualifications with inversion and Top 10 positions in Car Owner Points locked into the Main Event depending on qualifying times. Positions 21 through 24 shall be based on current 2007 Owners points. Positions 25 and 26 will be for past champions, if all past champions are already in the field, then the next two fastest based on qualifying times will be added to the starting field.
